Motion 23J, from Bryron Porter & Mark Smith: "That DTE purchase a UHF 40 channel CB Radio complete, valued at \$945.00 (Tandy)." Moved: for Byron by Laurie, Second: M. Smith, Voted For: 0, Against: 4, Lost.

Motion as published: Motion from Byron Porter, "That DTE purchase a UHF 40 Channel CB radio complete, valued at approximately \$945.00 (Tandy)", Rationale: The People on site (early) often don't have a vehicle or phone facility. For the safety of site set-up workers (in case of accident or security needs) I feel that this is an important safety tool. Seconded, Mark Smith.

communications available on site, Michael J. to be consulted about possible solution.

#### Motion 12R, from Bryron Porter in Byron Bay:

**Motion 3R, from Paul Grant:** "That the DTE Society establish a disputation fund of \$5000.00 to allow any member to institute legal proceedings in the Supreme court, or elsewhere as defined in the Co-operatives act 1996, where there is evidence of misconduct by a director or officer of DTE co-op. contrary to the interests of the Society as a whole. Misconduct as defined in the above Act and/or in the Corporation Law Act or the Commercial Arbitration Act." **Moved:** Paul Grant, **Second:** Jessika Willis.

Amendment: "That it includes in supporting members from other members from liable or slander." (?? I only type this stuff, MJ)

Main Motion with Amendment: "That the DTE Society establish a disputation fund of \$5000.00 to allow, with the approval of an RGM and the Board, to institute legal proceedings in the Supreme court, or elsewhere as defined in the Co-operatives act 1996, where there is evidence of misconduct by a director or officer of DTE co-op. contrary to the interests of the Society as a whole. Misconduct as defined in the above Act and/or in the Corporation Law Act or the Commercial Arbitration Act." Voted: For; 1 Against; 13 Lost.

**Motion 9R:** (Paul Grant) to be withdrawn and resubmitted.

**Motion(s) 10R, from Kathy Taylor;** "That we commit \$6,894 for training of six people for crowd control by using system implemented by Pt' Chang training scheme."

"That the ConFest Safety Project be given a trial run for starters."

**Moved:** K. Taylor, **Second:** D.Cruise. **Carried;** with consensus.

Motion as published; ( and therefore approved. as no ammendment noted ?? ),

"That the Motion passed on the 7/11/96, which reads "Motion that we commit to \$6,894 for training of six people & forty people for crowd control by using system implemented by Pt' Chang training scheme". "That the ConFest Safety Project be given the minimal amount of money and given a trial run for starters." (We all know it worked out OK, just setting the record straight.)
