COMMUNICATIONS DISCUSSION GROUP

- Mike to be added to the discussion on 'Communication' on facebook
- No direct control over ConFest facebook page
- Kevin is always happy to discuss pinned posts and take on board feedback
- Tightening up communications across the website, facebook pages, developing the newsletter
- More accurate information transfer
- Part of General Resource Audit to assist Strawberry in Coordinating Workflow at working bees, before, during and after festival
- Don't want to rely on facebook we should be promoting Confest.org
- Active mail-out list needs to be cleaned up with active registered users only
- ConFest FB page is not official however we can use it to direct users to the official Confest.Org
- Soon to be moving to Google docs to improve reporting functionality

RESOURCE AUDIT

- Work Schedules being developed
- Start of reporting spreadsheet
- Policies and Procedures
- Health and Safety
- Asking anybody who has info to pass on to Lawrie such as process documents, set up schedules etc
- Risk Analysis Plan Security etc, Carol has one for Easter
- Emergency Response Risk Assessment
- Issue with documents being dispersed to the room to the committee. There needs to be a central depository
- Has anyone asked for them? They are openly available
- Is there going to be Confest at Easter? Yes
- Information is produced but passing on the information is where it falls over
- Board feels defensive of being accused of withholding information
- Info is there but if it is in a central pool then all can access it. At a later date if required

TOILETS AND COOKING CIRCLES

- Need to finish project and need budget How Many and How Much?
- Cooking Barrels need to be finished
- January is dead...Budgets need to finalised in December for Easter in future so that activities, working bees can occur in future
- If we don't do it now we run the risk of not getting it done
- Every year Easter is not prepped till late Feb anyway
- It's risky and dangerous to have people on site in Jan/Feb Board has decided it's not safe
- Too risky because people work in heat...but Farmers are used to it
- Works program will dictate how much work needs to happen before Easter and schedule accordingly
- People can work with instructions regarding heat and Health and Safety
- Be prepared for the working bees so programs can be set that take in the early morn and arvo lower heat times
- Issues can be split into two Big en-mass Working Bees and small dedicated groups
- Such as the Barriers/Blockade gates that need to finished, the maintenance on the toilets Side Note not on Agenda:
 - What was wrong with the water supply to the kitchen at the last working bee? It was not filtered as per the Sept Working bee and people got ill
- Required by law to provide water to every kitchen. Filtered water

CONTAINERS:

- Poor storage in the Woolshed particularly the carpets and cushions being eaten by mice
- Fire and First Aid purchasing 4 Containers second hand -2 of which are forty footers
- Ordered and installed before Christmas
- One container is being used only for lime and toilet paper this can be moved to a smaller container
- Everything for the Woolshed could go in the 40 footer then lime and toilet roll can go to the 20 footer

MOTION SUGGESTION: 15th April 2 days before the festival, everything out to be used, everything else to be sorted to storage or thrown out in Big Skip

- 2.5 yrs ago there was a huge clearance and a huge load went to the local tip for only \$50/load
- Therefore don't need skip
- 20 footers are there for this purpose the Villages stuff that is used intermittently i.e some Villages
 don't set up every festival and don't always use the same set-up
- So need to have process for Villages to audit their own stuff
- Not every Village leaves stuff on site such as Rainbow, Teepee Village, General Stuff
- On many occasion stuff doesn't return to Confest from the Villages
- Many items come to Confest already from hard rubbish...the ethic is some cases is to use it that festival and if it gets decimated then dump it

NOTES FOR CONSIDERATION: Budgets – Take into account that if you give some Villages other V's equipment then next year they will apply for that same item in their budgets as replacements

- This is common and happens all the time
- How do we track the Assets and Budgets of each Village?
- MOTION: On the 15th April 2014 at 4pm Calling all Village representatives to come and take their items out of the Woolshed – Need to Notify all Villages of this
- Motion should be on-line for whoever wants to vote
- Mike suggested that they take out what they want for the Festival then put back in the 40 Footers...whats left can be sorted as per discussion?

ACTION: ONLINE DISCUSSION ABOUT CONTAINERS - Elle to initiate

COMPOST:

We can't put compost on Native plants its that simple if we keep compost where do we put it?

MARKET:

- Market Applications: Scouse has done great job but paper work needs attention.
- Scouse's Policy statement really needs updating
- Dawn and Jack have done a great job
- Ideally form a Market Sub Committee of 3 people
- Hagai New Market Application with a lawyer to review

MOTION: Stall Holders will have to supply a 6 x 3m shaded resting area – the food stalls Why this would help with the problem of where to put the Markets as the shaded areas could be used for other purposes...
