#### **Gary Lasky**

Meeting on Wednesday night for further information. The Board was never sent an invitation it went straight to Facebook. We never approved the 5 -6 week Bee. There are 256 members, the way he promoted it...all 256 would have the opportunity to attend the working Bee. We have requested risk management , safety and fire. We need to submit certain documents to council. Still much work to accomplish before the Board can approve. The 256 members are entitled to attend based on the request for what it was based on this working Bee.

Martin said some directors are familiar with what is going on and not every director is approving it unless the requirements are met.

#### **Lindy Hunt**

So, I wanted to touch on a couple things, initially Marte said all 24hour volunteers and members and a friend at which point that is 600 people and we need to keep numbers low. I asked him what numbers he was thinking of, he said 100 -150. I and it brought down to 100 this may be why he is being selective, but in all previous motions it states that it is open to all members and 24-hour volunteers. So, for long term members who have regularly turned up to a working bee for them to be rejected seems disgusting to me. I'm also curious about the motion by circular and I understand that the Board is responsible for all that happens on site. So if the working bee goes ahead and there is an accident with the tractor and someone gets injured the board would be responsible even though they've given the facilitators authority – I'd like some clarity on that from some of the directors if possible.

#### **Suzie Helson**

I'd like the organizing committee to make an action task – what is stopping the OC from compiling correspondence, whether it's the volunteers coordinator or, and the facilitators, the actual crew that are running the EWB2022. We need to see a list of attendees so we see the numbers as well as any members that may be banned from onsite. Marte Kinder in his form that he sent me the link he actually says the reason for this form is they have their covid plan their WHS and emergency evacuation as some of their systems that rely on the completion form. They obviously have a plan of some sort but, they need to communicate with the OC to show those plans.
