It requires the Board to consider applications from members or visitor(s) to enter any DTE site. The Board may grant approval for the applicant(s) to enter the site subject to any condition(s) they require. There have been alternate worthy proposals suggested to expediate the workings of this policy. However there have been several instances of non-compliance. Maintenance of a correct record of applications to visit the sites and then arrivals / departures for those granted is important to ensure compliance with external authority requirements, for the safety of visitors and security of assets. The current policy does not mention what should be done in cases of unauthorised entry. Therefore I request DTE members consider various incentives and sanctions to encourage compliance with the current policy regarding access to DTE properties.
